

## Cricut Joy Xtra™ ONE (1) YEAR LIMITED WARRANTY

This LIMITED WARRANTY is between you and Cricut, Inc., d/b/a CRICUT®.

Your Cricut Joy Xtra™ machine (the Product) is guaranteed against defects in materials and workmanship for a period of one (1) year from the date of its original retail purchase, or for California residents only, from the date of its delivery ("Warranty Period"). If a defect arises during the Warranty Period, Cricut, at its option, will (1) repair the Product at no charge using new parts or parts that are functionally equivalent to new in performance, (2) exchange the Product with a functionally equivalent product that is new or equivalent to new in performance, or (3) refund the original purchase price. This Warranty excludes damage from abuse, accident, misuse, physical and/or software modifications, or other causes that are not defects in materials and workmanship. Do not operate the Product in temperatures above 104°F (40°C) or store the Product in temperatures above 122°F (50°C). Operation or storage in temperatures in excess of the stated temperatures voids this Warranty. Any recovery is limited to the original purchase price. No other person/entity may modify this Warranty, and your retail seller is solely responsible for any other warranties.

This Warranty applies to the Cricut Joy Xtra™ machine. It does not apply to blades and blade housings, accessories, packaging, software, tools, materials, or other non-machine items. Cricut does not guarantee or warrant uninterrupted use of Product or its supporting software.
